#### Planning Applications

Winterbourne

- a) **P24/00550/TRE Bridge Bungalow, Old Gloucester Road Hambrook (**Works to fell 4no. Ornamental Cypress covered by TPO 0832 dated 10/02/2014.)
- b) P24/00568/PNH Bridge Bungalow, Old Gloucester Road, Hambrook (The erection of a single storey rear extension, which would extend beyond the rear wall of the original house by 8m, for which the maximum height would be 2.79m, and for which the height of the eves would be 2.79m. (Resubmission of P24/00197/PNH).
- c) **P24/00558/CLP 30 Stone Lane Winterbourne Down** (Renovation of existing outdoor store to garden outbuilding.)

P23/03164/F - Land Centre of Pond, 31M from Pleasant View, Bury Hill (Erection of 1no. agricultural building, resurfacing of hardstanding/driveway and associated works.) REFUSAL. The Parish Council raised an Objection.

P23/02578/HH – 10 Frome Way (Installation of raised patio. (Retrospective). APPROVE WITH CONDITIONS. The Parish Council did not raise an Objection.

P24/00197/PNH – Bridge Bungalow Old Gloucester Road Hambrook (The erection of a single storey rear extension, which would extend beyond the rear wall of the original house by 8m, for which the maximum height would be 3.73m, and for which the height of the eaves would be 3.73m.) PRIOR APPROVE OBJECTION (PNH) The Parish Council did not raise an Objection.

P24/00026/TCA - 3 The Observation Pavilion, Alexander Road (Works to 1no. Lime to reduce height and reshape by 30%, raise canopy height to 3m, crown thin by 25% and remove major dead wood situated in the Frenchay Conservation Area.) NO OBJECTION. The Parish Council did not raise an Objection.
