### **160.03/25 Planning Applications**

#### **Winterbourne**

- a) **P25/00432/HH - The Oak 34A Bristol Road Winterbourne** (Erection of a single storey rear extension to form additional accommodation). **Resolved**, The Parish Council did not raise an objection.
- b) **P25/00417/TRE - Blossom Fields 84 - 86 High Street Winterbourne** (Works to crown lift 1no Horse Chestnut Tree by 5m. Works to 1no Beech Tree to reduce the top 2 branches leaving 1-2m. Covered by tree preservation order SGTPO 01/06 dated 8th June 2006). **Resolved**, The Parish Council did not raise an objection. However, consideration of the timing of works in regards of nesting season. Are there any remedial works planned for the roots where the wall is being damaged.
- c) **P25/00426/HH - River Mill Cottage Bury Hill Hambrook** (Alterations to existing detached garage to form additional living accommodation). **Resolved**, The Parish Council did not raise an objection.
- d) **P22/07094/RM - Land North Of The Railway, East Of Harry Stoke** (Erection of 154no. dwelling with highways, drainage and associated works with appearance, landscaping, layout, and scale to be determined. (Approval of Reserved Matters to be read in conjunction with outline permission P21/06474/RVC (previously

PT16/4928/O)). **Resolved**, The Parish Council are unable to comment due to the volume of new documentation and no explanation of actual changes.

#### Frenchay

- e) **P25/00300/HH - 5 Westbourne Terrace Frenchay** (Erection of a detached single garage). **Resolved**, The Parish Council did not raise an objection. However, the Parish Council echo the Conservation Officer comments to use materials in keeping with the area.
- f) **P25/00070/RVC - Frenchay Village Museum 1 Begbrook Park Frenchay** (Variation of condition 4 (approved plans) attached to planning consent P20/17040/F - Demolition of existing garage and extension. Erection of two storey and single storey side extensions to form display area and office (Class F1c). **Resolved**, The Parish Council did not raise an objection. The Parish Council believe this is a great asset to the village and this addition will enhance the museum and enable it to be used far more easily with the extra space, especially for Frenchay Primary School pupils nearby.
- g) **P25/00414/F - 9 Old Gloucester Road Frenchay** (Subdivision of 1no. dwelling into 2no. dwellings with associated works). **Resolved**, The Parish Council did not raise an objection. However, the Parish Council do not accept that EV requirements should not be considered, especially for starter homes.

P25/00041/TCA - 1 The Common Frenchay Common Frenchay (Works to 1no Holm Oak Tree (T1) to Crown reduce height by 3m and radial spread by 1m within Frenchay Conservation Area). NO OBJECTION. The Parish Council did not raise an objection.
