170.03/25 - Chairs' Announcements

Chair advised that the office staff are unusually busy at present dealing with three tenders that are currently open and maintenance issues with The Greenfield Centre. Chair asked members to report issues themselves if they are able. Also, to try and respond to emails in a timely manner.

Chair reminded members that information and documents are put on the hub and to familiarise themselves prior to meetings.

171.03/25 – Public Participation

Members were thanked for their assistance with the residents meeting regarding the Elm Park waiting restrictions consultation. In particular Cllr Sykes.

Two members of the public raised the issue of traffic safety near their property. There have been many accidents and wanted to know what the Parish Council can do about it. They have already contacted South Gloucestershire Councillors but have not had any response. Chair advised that a Parish Council has no jurisdiction over roads and highways but can pass on comments on a residents behalf. Cllr Labuschagne advised that South Gloucestershire Councill Jones was in contact with Highways and will ask him to contact the member of the public with an update. Cllr Collins suggested a temporary speed visor in the interim. Cllr Labuschagne to contact SG Cllr Jones. Clerk to investigate possibility of speed visor.

174.03/25 - To receive and consider the Clerk's Report and Actions Update All items on the Clerks report were noted.

- ❖ We have placed tree stumps on the grassed triangle at Whiteshill Common as they were free and the boulders would have cost around £200.
- Community Coppicing Sessions have bene promoted on our social media
- ❖ UPVC window replacement tender is live and ends on 21st March. Quite a few companies have done a site visit.
- ❖ The structural engineer has visited the Tennis Pavilion and we are awaiting the report.
- ❖ Pavilion Refurbishment: Three site visits have taken place so far with two more booked for w/c 3rd March. Frustratingly, we are being asked for further information which we were unaware of, including an asbestos survey.
- ❖ A meeting took place with our insurance broker to clarify the parish council's position with regard to fidelity insurance and roof insurance. Broker will contact AXA to clarify.
- Two amazing community engagement events took place. The Owl show and tell, which had over 70 attendees and the Frenchay Primary walk to school fruit tree planting day. In total over 40 trees were planted including those in Tuckett Field.

Current Outstanding Actions From Previous Council Meetings

- ❖ A response has been received from Marc Cashmore, SGC, regarding the issue of a single bollard not being sufficient at the end of the walk to school path, Beckspool Road, Frenchay. He has offered to meet and discuss. Email sent to Frenchay members and Cllr Eldridge who raised the issue. 2/12: Cllr Eldridge advised he has been in contact with Marc Cashmore, who is looking into this. Cllr Eldridge is awaiting an update. 6/01: Cllr Eldridge absent from meeting. 03/03: Cllr Eldridge advised he has received correspondence from Marc Cashmore advising that there is not much more he can do and is investigating putting a chicane further down the path. Item to be closed and re-opened if any further information received.
