Winterbourne

- a) **P25/00481/HH - Old Sarum House 1 Mapstone Close Hambrook** (Erection of a louvred pergola and single storey detached outbuilding to form home office and store). **Resolved**, The Parish Council did not raise an objection.
- b) **P25/00455/HH - The Willows Common Mead Lane Hambrook** (Erection of first floor side extension over garage to provide additional living accommodation). **Resolved**, The Parish Council did not raise an objection.
