#### Winterbourne

- a) P25/00592/HH 28 Green Dragon Road Winterbourne (Erection of a single storey rear extension to form additional living accommodation). Resolved, The Parish Council did not raise an objection.
- b) P25/00749/HH 1 Linden Close Winterbourne (Erection of single storey side and rear extension and conversion of existing garage to form additional living accommodation). Resloved, The Parish Council did not raise an objection. However, the Parish Council do have concerns over how close the gas pipeline is.
- c) P25/00778/HH 44 Mount Cresent Winterbourne (Erection of side and link extension to existing garage to facilitate conversion to annexe ancillary to the main dwelling (resubmission of P24/03004/HH). Resolved, The Parish Council did raise an objection. The Parish Council still have concerns about parking on this overdeveloped plot.
- d) **P25/00820/HH 53 Friary Grange Park Winterbourne** (Erection of front porch. Erection of a single storey rear extension to form additional living accommodation). **Resolved**, This Parish Council did not raise an objection.
- e) **P25/00854/HH 11 North Road Winterbourne** (Raising of roofline and installation of 1no rear dormer to facilitate loft conversion. Erection of single storey rear and two storey side extensions to form additional living accommodation (amendment to

- approved scheme P23/01702/HH). **Resolved**, The Parish Council did raise an objection due to the lack of information.
- f) P25/00692/LB Hambrook House The Stream Hambrook (Retention of external works for the removal of cement render and application of lime render on south elevation). Resolved, The Parish Council did not raise an objection.
- g) P25/00648/HH The Tythings Bristol Road Hambrook (Conversion of existing detached garage to create office/gym with bathroom facilities and storage above, and installation of enlarged concrete hardstanding in garden). Resloved, The Parish Council did raise an objection. The Parish Council feel this is an inappropriate development to a Grade II listed building.
