# 78.09/25 Planning Applications

#### Winterbourne

- a) P25/02023/HH 54 Friary Grange Park Winterbourne (Erection of two storey and single storey side and rear extension to form annex ancillary to main dwelling, and erection of single storey rear extension to form additional living accommodation to main dwelling). Resolved, the Parish Council did raise an objection. The Parish Council feel that this would be an overdevelopment of site what appears to have the potential of being two dwellings on one plot. There is a possibility of six bedrooms resulting in inadequate parking.
- b) **P25/02041/TRE 20 Manor Lane Winterbourne** (Works to 1no. Oak to crown lift to 3.5m all around and crown reduce to previous points covered by TPO 1108 dated 29/06/2021). **Resolved, the Parish Council did not raise an objection.**
- c) P25/02037/F UWE Hillside Gardens Filton Road Winterbourne (Installation of an electronic scoreboard and siting of a shipping container for the storage of sports equipment and associated works). Resolved, the Parish Council did not raise an objection.

P25/01709/TCA - Old Manse, Bristol Road (Works to crown reduce 1 no. Apple tree (T1) to leave a finished height of 4.5 m and radial spread of 4 m, 1 no. Apple tree (T2) to leave a finished height of 4.5 m and radial spread of 4 m, 1 no. Crab Apple tree (T3) to leave a finished height of 4.5 m and radial spread of 4 m, and 1 no. Holly (T4) to leave a finished height of 4.5 m and radial spread of 3 m. Trees situated in the Hambrook Conservation Area). NO OBJECTION. The Parish Council did not raise an objection.

P25/01643/HH - Montrose 7 Branksome Drive Winterbourne (Erection of single storey rear extension to form additional living accommodation). APPROVE WITH CONDITIONS. The Parish Council did not raise an objection.
