71.09/25 Clerk's report and action update

A meeting was held with Western Building Consultants to discuss the additional costs to the pavilion refurbishment and to discuss rendering options. Cllrs Kembery and Watkins also attended site with Western Building Consultants.

The final form to receive the Government loan has been submitted and, hopefully, funds will be transferred next week.

A representative of Robyn Maggs attended a pavilion site visit with CGW to look at the bar and kitchen area.

Winterbourne Sports Association have been advised that there will be no grant funding for new furniture for the pavilion clubroom. They will set up a 'go fund me' page.

The Annual Governance and Accounting Review (AGAR) has been returned from the external auditor. There were no concerns raised.

Clerk sent the East of Harry Stoke boundary line to members.

A letter has been sent to National Trust regarding the easement request.

No further information has been received regarding the request for an additional youth team to play at Hambrook Common.

Frenchay

A meeting was held with Frenchay museum where it was agreed to help provide them with WIFI so the Parish Council could also use it for the CCTV in the car park.

Residents have been asking how to fish at the Duck Pond – **Clerk will update the website**

Concerns raised regarding potential development of the Silverhill Site. Cllr Bruce advised that the local listing application has been submitted. Noted that no planning applications are on the South Gloucestershire Council planning portal.

The Dingle, Winterbourne Down and Hambrook

Noted that the high volume of road works has caused disruption in Hambrook.

Cllr Fogg-Rogers advised that a petition has been created for a crossing at Whiteshill Common

The Greenfield Centre

Noted that people are parking on the hatched area by the defibrillator as they are quite faded. **Clerk to get the hatched area re-painted.**

RESOLVED, to produce a user agreement for anyone using Whiteshill Common. To include a condition to attend the Hambrook Commons Committee Meeting. **Clerk to produce agreement and present at the next Full Council Meeting.**

75.09/25 To discuss, and make agreement on withdrawing funds from the Nationwide Savings Account

Clerk advised that Redwood Bank had denied the emergency withdraw request.

Proposal to apply to Nationwide Savings Account for an emergency withdraw and, if successful, cancel the Redwood 95 day notice withdraw.
