# 94.10/25 - Chairs' Announcements

Chair read a statement regarding the flags in Winterbourne.

There have been discussions on social media locally on the flying of flags. Some residents have contacted Winterbourne Parish Council and suggested that the Union Jack and St George flags should not be on our flag poles. South Glos. Council have advised us they will start taking down unauthorised flags, of which there are many locally. It will cost the council on removal from roundabouts and other places where St George crosses and others have appeared.

There has been a debate nationally on whether flags represent pride or prejudice. I would like to state that Winterbourne Parish Council, regardless of the arguments for or against the flying of flags as noted at the opening statement in our agenda this evening says 'Members are reminded that Council has a general duty to consider the following matters in the exercise of any of its functions: Equal Opportunities (race, gender, sexual orientation, marital status, and any disability) Crime & Disorder, Health & Safety and Human Rights.'

In light of the synagogue attack last week in Manchester and other recent events, I would suggest that more than ever our community must try and live with compassion and tolerance and be a place to feel proud to live in.

This is not an agenda item for discussion but I'm sure everyone here understands why there is a need to make our views clear.
