97.10/25 Planning Applications

Winterbourne

- a) **P25/02235/F - Land And Buildings At Wayland Stables Beacon Lane Winterbourne** (Change of use from sui generis (dog day care) to sui generis (care farm) as defined in the Town and Country Planning (Use Classes) Order 1987 (as amended). **Resolved, The Parish Council did not raise an objection.**
- b) **P25/02298/CLE - Land At Sunny Acres Farm Factory Road Winterbourne** (Installation of above ground concrete valve house including associated steelwork, steps, and safety railing, is required to house flow control equipment to regulate and manage flow of wastewater). **Resolved, The Parish Council did not raise an objection. However, The Parish Council would like the applicant to consider screening the structure with trees/vegetation.**
- c) **P25/02297/CLE - Land At Sunny Acres Farm Factory Road Winterbourne** (Installation of below ground stormwater storage tank, 1no. control kiosk, ground level vent; 1.2m high fence, below or at ground level manholes and associated below ground pipework and rising main and ground level concrete and grasscrete track). **Resolved, The Parish Council did not raise an objection.**
- d) **P25/02213/F - The Elms 43 Dragon Road Winterbourne** (Creation of vehicular access onto classified road (Class C) and installation of hardstanding to form car parking space). **Resolved, The Parish Council did not raise an objection.**

Frenchay

- e) **P25/02244/RVC - Shaftesbury Park Frenchay Park Road Frenchay** (Variation of conditions 4 (to amend the hours the sports pitches can be used) and 6 (to amend the hours live music can be played) attached to permission PT15/0493/F. Demolition of existing derelict buildings and development of a new community sports facility for relocation of Dings Crusaders Rugby Football Club comprising all weather sports pitch and grass rugby pitches (including floodlighting to two pitches), erection of clubhouse building (including community sports hall, changing rooms, spectator seating and viewing area, function/meeting rooms and club shop), car parking, creation of new vehicular and pedestrian/cycle accesses, grounds equipment area and fencing, landscaping, sustainable urban drainage and associated infrastructure works). **Resolved, The Parish Council did raise an objection. The Parish Council noted that the noise survey was not done at a representative time for an example summer. The Parish Council would like more detail regarding the noise monitoring and would recommend a trial at a more realistic time.**
- f) **P25/02302/TCA - Penn House Beckspool Road Frenchay** (Works to 1no. Norwegian Maple and 2no. Yews to reduce back to previous pruning points and root lift to 4m all situated in the Frenchay Conservation Area). **Resolved, The Parish Council did not raise an objection.**
- g) **P25/02311/F - The Acorns 35 Penn Drive Frenchay** (Demolition of an existing garage and erection of 1no. single storey ancillary annexe). **Resolved, The Parish Council did not raise an objection. The Parish Council would like a condition that the annex remains ancillary to the main dwelling.**
