- a) **P26/00689/LB - Frenchay C Of E School Church Road Frenchay** (Internal alterations with the installation of secondary glazing to windows; demolition of partition wall in room c; removal and replacements of 1no. door each in room d and e; installation of partition walls on first floor). **Cllr Collins left the room. Resolved, The Parish Council did not raise an objection.**
- b) **P26/00775/CLP - 49 Alexander Road Frenchay** (Erection of single storey rear extension). **Resolved, The Parish Council did not raise an objection. However, The Parish Council note the loft conversion is not in the description.**

- c) **P26/00758/TRE - James Counsell Way Stoke Gifford** (Works to remove failed branch from canopy of 1no. Willow Tree (T22) and remove fractured limb from 1no lawson cypress Tree. Works to fell 2no. Horse Chestnut Trees (G6), 2no. Norway Spruce Trees and 1no. Holly Tree. Covered by Tree Preservation Order SGTP007/14 dated 1st July 2014). **Resolved, The Parish Council did raise an objection. The Parish Council note that there is no reason for removal of the horse chestnuts, there are no replacement trees. There is no arboriculture report that the Parish Council feel that South Gloucestershire Council tree officers should request one. The Parish Council feel this is a poor and disappointing application.**
