62.09/22 - Notice of bereavement of a former councillor

David Fletcher sadly passed away on 25th August after a battle with cancer. David joined Winterbourne Parish Council in 1991 and retired in 2019, serving many years as Chair and Vice Chair and also as Chair and Vice Chair of the Planning Committee. He was a South Gloucestershire Councillor for 4 years and always had an interest in planning. He was also the Chairman of Frenchay Preservation Society and a member for many years. He continued with this even after he moved to Mangotsfield. David was passionate about Frenchay and the wider surroundings and many residents and councillors will reflect on this and the wider roles in politics he was involved in. A Frenchay resident said to me a week ago he was 'a real character'. His funeral will take place on Tuesday 20th September at Westerleigh Crematorium at 3.30pm, followed by refreshments in the adjoining Willow Tree Café. Councillors and the Clerks are welcome to attend and please liaise with Tim Bowles so numbers can be accommodated.

A 2 minute silence was held to remember David.

 <u>66.09/22 – To answer questions from Councillors</u> Cllr Dyer is going to help clear the area in Tuckett Field behind where the new wall has been built. There is a large patch under an Ash tree which may need some reseeding. It was noted 2 Horse Chestnut trees on Hambrook Common are not looking very good and this is thought to be due to the drought conditions which have affected Horse Chestnut trees badly. The cancellation of the bus routes through Winterbourne was discussed. The Parish Council would like to raise awareness of how badly this will affect residents. Firstly Cllr Jones, in his role as South Gloucestershire Councillor, will qualify with South Gloucestershire Council what their position is on the subject. Cllr Collins advised that there are 4 wild flower areas in Frenchay and the Duke of Edinburgh students he has been mentoring will cut these this year and then the contractor will clear the cuttings. 67.09/22 – The Head of Elm Park Primary School to give an update on the progress of the new school building. The Head was unable to attend and sent apologies. It is hoped they will attend the October meeting.			
 <u>68.09/22 – To receive and consider the Clerk's Report</u> <u>All items on the Clerk's Report were noted.</u> A query was raised in the last Council Meeting as to whether Councillors could opt out of being filmed in a meeting. The right to record, film and to broadcast meetings of Local Councils, committees and sub committees was established following the Local Government Audit and Accountability Act 2014. The "Openness of Local Government Bodies Regulations 2014" became active legislation in August 2014. This is in addition to the rights of the press and public to attend such meetings. Councillors do not have the right to refuse being filmed. Some further investigation will be done into how this affects members of the public. The play equipment for the Recreation Ground and trim trail equipment for Hambrook has been ordered. A start date of the 3 October has been given for the Rec. Before work can start at the Rec the area of land needs to be levelled. Cllr Dyer will liaise with the Clerk to determine the work involved in this. 	Clerk P Dyer Clerk

74.09/22 – To consider passing a resolution to sign up to the Civility and Respect Pledge

Members considered the details of the pledge and feel the principles are already recognised within our existing Code of Conduct. **Resolved** not to sign.

75.09/22 - To consider the WECA Bee Bold Pollinator Grant Fund

The aim of this scheme is to provide funds to do the following:

- To create and enhance the biodiversity in the area with the emphasis on improving pollinator habitats to contribute towards the regional ambition to increase the abundance of wildlife by 2030.
- To raise awareness and empower communities to take action to address the ecological emergency.

The Local Nature Action Plan (LNAP) currently being considered by the Council has already identified Tuckett Field in Frenchay, a Winterbourne Parish Council asset, as being a priority for this scheme.

Applications must have a level of at least 20% match funding / contribution. A substantial amount has already been pledged by local benefactors which could mean that there will potentially be no cost to the Parish Council.

Resolved that councillors give permission for the application to be made to WECA and that the Parish Council will underwrite funds if required to make up the shortfall until all funding is received.

Proposed Cllr Bowles, seconded Cllr Jenkins. All members in favour.

<u>76.09/22 – To consider a solution to unlawful parking on the Small Common at</u> Frenchay

There has been a problem with vehicles parking on the Common.

Resolved to put an additional sign there advising no parking is allowed according to the byelaws. The situation will continue to be monitored by the Frenchay Councillors. Clerk will to obtain.
