

External auditor report 2021/22

On 27 September 2022, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2022. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review.

- The council has confirmed that Section 2, Boxes 4 and 6 for 2020/21 are incorrect and should read £51,751 and £144,996 respectively.

The council did not hold an Annual Parish Meeting during 2021 in accordance with the Local Government Act 1972 and therefore should have responded 'No' to Section 1, Assertion 3.

Other matters not affecting our opinion which we draw to the attention of the authority:

The council actively uses task groups. There should be terms of reference, governance matters and details of how the task groups should report back to the Finance and General Purpose Committee in place. Matters and procedures in respect of task groups should be made transparent within the published Standing Orders.

We were unable to identify information in respect of the budget setting process or the earmarked reserves as at 31 March 2022 on the council's website. Furthermore we recommend the council undertakes regular budget monitoring, that it is specifically identified within the minutes of the meeting and that the review currently carried out by the Finance and General Purpose Committee is formalised.

We recommend the council should consider implementing and approving an investment strategy policy as a matter of best practice given the value of cash and short term investments held.

We remind the council to ensure it sets the scope of the engagement of the internal auditor and regularly reviews and approves the appointment of the internal auditor in accordance with its financial regulations. The council's minutes should demonstrate that this process has been completed each year

We received challenge correspondence in relation to the 2021/22 AGAR which we considered before completing our work. The authority will receive an invoice in relation to this additional work.
